**PLEASE NOTE:** Pursuant to the 15<sup>th</sup> Judicial District Court's Second Supplemental Emergency Order Relative to COVID-19 Public Health Emergency signed by Chief Judge Marilyn Castle on March 19, 2020, which expires on April 9, 2020, at 5:00 p.m. unless extended, all non-emergency trials/hearings in Division "M" are being reset.<sup>1</sup> You will be notified by the Clerks of Court of the new hearing dates, which are summarized below for your convenience.<sup>2</sup>

### 1. Clearstart Docket for Monday, March 30, 2020:

All matters on the Lafayette Parish Clearstart Docket for Monday, March 30<sup>th</sup> are being reset to Friday, April 17, 2020, at 9:00 a.m.

### 2. Adoptions and Pre-Trial Conference Set for Monday, March 30, 2020:

The two adoptions set for March 30<sup>th</sup> at 11:00 a.m. and 2:00 p.m., respectively, have been reset to Friday, April 17, 2020. The time for each adoption has not changed. For example, the adoption originally set for March 30<sup>th</sup> at 11:00 a.m. will now be heard on April 17<sup>th</sup> at 11:00 a.m.

The pre-trial conference scheduled for March 30<sup>th</sup> at 1:00 p.m. has been reset to Friday, April 17<sup>th</sup> at 1:00 p.m.
