

**UPDATED MEMO FROM THE LAFAYETTE CITY COURT JUDGES (4/5/20):**

**LAFAYETTE CITY COURT BUILDING CLOSURE AND  
AVAILABILITY OF LIMITED COURT OPERATIONS**

**ALL COURT SESSIONS SCHEDULED TO BE HEARD PRIOR TO MAY 15, 2020 HAVE BEEN CANCELLED AND WILL BE RESCHEDULED BY THE COURT. THE LAFAYETTE CITY COURT BUILDING REMAINS CLOSED TO THE PUBLIC HOWEVER LIMITED STAFF ARE WORKING TO HANDLE COURT MATTERS RECEIVED BY MAIL OR FAX. PHONE MESSAGES ARE ALSO BEING RETURNED AS SOON AS POSSIBLE. THE CITY COURT BUILDING IS SCHEDULED TO BE REOPENED TO THE PUBLIC BEGINNING MAY 4, 2020. THE COURT HOPES TO RESUME LIMITED COURT SESSIONS BEGINNING MONDAY, MAY 18, 2020. THE COURT EXPECTS TO RETURN TO ITS NORMAL COURT SCHEDULE BEGINNING MONDAY, JUNE 15, 2020.**

**ADDITIONAL INFORMATION:**

- **INFORMATION AVAILABLE ON WEBSITE:** Many people can view information, including updates from the court or their case status by going to our website, <https://www.citycourtlafayettela.org/Home.aspx>. If you have trouble getting to the website, type "City Court Lafayette Louisiana" and a link should appear on your search engine;
- All persons having business with the City Court of Lafayette, Louisiana can continue to file civil pleadings, evictions, criminal pleadings and other matters with the appropriate department via fax or U.S. Mail;
- All civil pleadings, new petitions including new eviction proceedings, answers or other pleadings can be faxed to the court's civil department at (337) 291-8771 in accordance with Louisiana Code of Civil Procedure Article 850;
- All criminal/traffic motions or other filings can be faxed to the court's criminal/traffic department at (337) 291-8774;
- The court's mailing address is Post Office Drawer 3344, Lafayette, Louisiana 70502-3344;
- All criminal and traffic arraignments sessions that have been cancelled during this period are being reset beginning in the month of July. Exact dates will be confirmed and notices mailed in June, if not sooner;
- All civil, criminal and traffic trials that are scheduled on or before May 15, 2020 are cancelled and will be rescheduled for after June 15, 2020. It is most likely that special

sessions of court will be scheduled to accommodate the expedited handling of cancelled matters;

- No decision has been made on the Juvenile matters scheduled for May 14, 2020 and May 21, 2020. Those parties will be notified by the court should the session(s) be rescheduled;
- If you are the attorney of record, you will be contacted prior to your matter(s) being rescheduled. The Court intends on holding a status conference by video or phone with all attorneys in both civil and criminal matters. This includes cancelled cases handled by the Public Defender's Office;
- If you do not have an attorney and you have a criminal matter and cannot afford to hire an attorney; you should contact the Public Defender's Office at (337) 232-9345;
- If you have questions concerning civil matters and you cannot afford an attorney, you should contact the Acadiana Legal Services' office at (800) 256-1175. If you have civil matters that were cancelled, every effort will be made to contact you by phone or mail (if we have a valid address or phone number).

#### **FAQS:**

- **HAVE ALL MATTERS ALREADY BEEN RESET:** No, not all matters have been reset as the court is waiting for a more definite start date. Some court matters have been tentatively rescheduled, but those dates could change;
- **HOW WILL I KNOW MY NEW COURT DATE:** A notice will be mailed to all defendants once the Court is satisfied that it can hold court sessions. It is the defendant's responsibility to ensure that the court has a current address. If your address has changed, you must provide the new address in writing to the court by mail or by fax at (337) 291-8774. The court's mailing address is Post Office Drawer 3344, Lafayette, Louisiana 70502-3344. You must include your full name as it appears on your old notice, your docket number and your new address including city, state and zip code. You can also provide a contact phone number and/or email address;
- **DO I NEED TO CALL THE COURTHOUSE TO HAVE MY CASE RESCHEDULED:** No. All cases originally scheduled on or prior to May 15, 2020 will be reset and the court will send notice to the last address on file. If your address has changed, please see the above paragraph.

- **IN WHAT ORDER WILL CASES BE RESCHEDULED:** All cancelled matters will be given a rescheduling priority but it is unlikely that any case will be rescheduled before May 15, 2020;
- **I RECEIVED A TRAFFIC CITATION THAT I AM NOT CONTESTING, CAN I PAY THE FINE ONLINE:** Yes, most traffic tickets, and some previously resolved criminal matters can be paid online by credit card (processing fee applies) by using the Court's website, <https://www.citycourtlafayette.org/Home.aspx>. Traffic and criminal fines can also be paid by mail with certified funds or money order, (do not send cash or personal check) payable to City Court of Lafayette, and mailed to Lafayette City Court c/o Traffic Violations Bureau, Post Office Box 2086, Lafayette, Louisiana 70502. If your ticket is court mandatory, you will not be able to pay it online. Those matters will be reset by the Court;
- **I AM SCHEDULED TO MAKE PAYMENTS ON A FINE THAT HAS PREVIOUSLY BEEN IMPOSED BY THE COURT AND MY PAY DATE WAS CANCELLED:** Some criminal fines can be paid online (see paragraph above for website). If your pay date was cancelled, it will be rescheduled. However, you may be able to make partial payments online. No warrant will be issued unless you miss the rescheduled date;
- **I HAVE TO COMPLETE PROGRAMS AS PART OF A SENTENCE BUT THE CLASS OR COMMUNITY SERVICE LOCATION IS CLOSED:** The court is aware of the situation and has automatically extended all completion dates. You will be notified of the new completion date once it is set by the court. No warrant will be issued because you did not complete your programs by the original completion date;
- **MY CHILD HAS A JUVENILE PROBATION AGREEMENT AND/OR COMMUNITY SERVICE HOURS, WHAT SHOULD I DO:** Many juvenile agreements are scheduled to be completed by May 21, 2020. If you have already completed your requirements or community service hours, fax a completion letter to the Court's Juvenile Department at (337) 291-8181. If you are not complete see FAQ paragraph above;
- **IS THE LIMITED AMNESTY PERIOD STILL BEING RECOGNIZED:** Yes, the limited amnesty period that was established by the Lafayette City Court Judges remains open. This applies to all parties with existing criminal or traffic warrants or driver's license forfeitures. During this period, warrants will be stayed for any person with an existing warrant or driver's license forfeiture that contacts the criminal/traffic department at the phone number listed below and provides the following: Identifying information,

including but not limited to race, gender, social security number, driver's license number (if any), and date of birth; and also provides a new physical address, phone number and email address. If so contacted, a new court date will be provided and the warrant/license forfeiture will be stayed until the new court date. Notice will be provided by regular mail to the defendant. Should the defendant fail to appear at the new date the warrant or forfeiture will be reinstated. Should the defendant appear, the warrant or forfeiture will be recalled and all previous contempt waived. This amnesty only applies if you contact the court. Until such time, the warrant or forfeiture remains active and the person can be arrested.
